General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
 - the scripts of the candidates specified on the bar code label provided
 - the supervisor's results relevant to these candidates
 - the supervisor's reports relevant to these candidates
 - seating plans for each practical session, referring to each candidate by candidate number
 - the attendance register.

Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do all the experiments and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.
If chemicals are prepared in more than one batch, clearly labelled supervisor's results must be provided for each batch. The candidates using each batch must be listed on the supervisor's report.

 OR additional 150 cm³ or 250 cm³ conical flask with one-hole bung connected to approximately 50 cm of plastic/rubber delivery tube
 1 × thermometer (−10 °C to +110 °C at 1 °C)
 1 × plastic or cardboard cup, capacity approximately 150 cm³
 1 × glass rod
 2 × teat/dropping pipette
 1 × spatula
 1 × tripod
 1 × gauze
 1 × Bunsen burner
 1 × heat-proof mat
 1 × test-tube holder
 8 × test-tube*
 1 × test-tube rack
 1 × wash bottle
 1 × pen for labelling glassware
 paper towels
 red and blue litmus papers
 aluminium foil for testing nitrate/nitrite
 wooden splints
 the apparatus normally used in the centre for use with limewater in testing for carbon dioxide

*Candidates are expected to rinse and reuse test-tubes where possible.
Additional tubes should be available.

FB 1	100 cm ³	0.30 mol dm ⁻³ HCl	Dilute 150 cm ³ of 2.0 mol dm ⁻³ HCl in each dm ³ . See preparation instructions in the current syllabus for 2.0 mol dm ⁻³ HCl.
FB 2	2.0 ± 0.1 g	powdered CaCO ₃	2.0 ± 0.1 g powdered calcium carbonate in a stoppered container.
FB 3 [C]	150 cm ³	1.00 mol dm ⁻³ NaOH	Dissolve 40.0 g of sodium hydroxide [C] in each dm ³ of solution.
FB 4	150 cm ³	2.20 mol dm ⁻³ HCl	Dilute 187 cm ³ of concentrated (35–37%; approximately 12 mol dm ⁻³) hydrochloric acid [C][MH] in each dm ³ .
FB 5	20 cm ³	0.20 mol dm ⁻³ H ₂ SO ₄	Dilute 200 cm ³ of 1.0 mol dm ⁻³ H ₂ SO ₄ [MH] in each dm ³ of solution. See preparation instructions in the current syllabus for 1.0 mol dm ⁻³ H ₂ SO ₄ [MH].
FB 6	20 cm ³	0.30 mol dm ⁻³ HCl	Same solution as FB 1 .
FB 7	20 cm ³	0.30 mol dm ⁻³ HCOOH	Dilute 11.3 cm ³ of concentrated methanoic acid (90% w/w) [C] to make 1 dm ³ of solution.
FB 8	20 cm ³	'10 vol' H ₂ O ₂	Dilute 100 cm ³ of '100 vol' hydrogen peroxide [C] to make 1 dm ³ of solution.
FB 9	20 cm ³	0.20 mol dm ⁻³ MgSO ₄	Dissolve 49.2 g of MgSO ₄ ·7H ₂ O in each dm ³ of solution.
magnesium [F]	8 × 2 cm lengths	magnesium ribbon	
distilled water	100 cm ³	distilled water	Provide in a beaker for each candidate.

dilute hydrochloric acid	10 cm ³	2.0 mol dm ⁻³ HCl	
dilute nitric acid [C]	10 cm ³	2.0 mol dm ⁻³ HNO ₃	
dilute sulfuric acid [MH]	10 cm ³	1.0 mol dm ⁻³ H ₂ SO ₄	
aqueous ammonia [C][MH][N]	10 cm ³	2.0 mol dm ⁻³ NH ₃	
aqueous sodium hydroxide [C]	10 cm ³	2.0 mol dm ⁻³ NaOH	
aqueous barium chloride or aqueous barium nitrate	10 cm ³	0.1 mol dm ⁻³ BaCl ₂ or 0.1 mol dm ⁻³ Ba(NO ₃) ₂	See preparation instructions in the current syllabus. If necessary, each of these reagents can be provided as a communal supply for groups of up to 6 candidates. Invigilators must be alert to the risk of contamination and the opportunity for malpractice when using a communal supply.
limewater [MH]	10 cm ³	saturated aqueous calcium hydroxide, Ca(OH) ₂	
aqueous silver nitrate	10 cm ³	0.05 mol dm ⁻³ AgNO ₃	
acidified aqueous potassium manganate(VII) [MH]	10 cm ³	0.01 mol dm ⁻³ KMnO ₄ in 0.5 mol dm ⁻³ H ₂ SO ₄	

- An excess of at least 10% of each material must be prepared to cover accidental loss.
- All solutions must be thoroughly mixed.
- If you are unable to source any of these chemicals, you must contact Cambridge International as far as possible in advance of the exam for advice.
- **Materials must be labelled only as specified in the 'label' column. The identities of chemicals labelled with letter codes, e.g. FB 1, may be different from their descriptions in the question paper. Candidates must use the descriptions given in the question paper.**
