## General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

### Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

### During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the bar code label provided
  - the supervisor's results relevant to these candidates
  - the supervisor's reports relevant to these candidates
  - seating plans for each practical session, referring to each candidate by candidate number
  - the attendance register.

## Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do all the experiments and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

If chemicals are prepared in more than one batch, clearly labelled supervisor's results must be provided for each batch. The candidates using each batch must be listed on the supervisor's report.

### Apparatus

The apparatus listed must be provided to each candidate.

 1 × 250 cm<sup>3</sup> plastic or glass measuring cylinder  
 1 × burette stand and clamp  
 1 × 250 cm<sup>3</sup> one-mark graduated volumetric flask (ISO1042 or grade B)  
 1 × 100 cm<sup>3</sup> beaker  
 1 × funnel (for filling burette)  
 1 × white tile  
 2 × stand and clamp  
 1 × tub suitable for acting as trough (minimum capacity 1 dm<sup>3</sup>)  
 1 × side-arm conical flask, labelled **X**, with bung connected to approximately 50 cm of plastic/rubber delivery tube **OR** additional 150 cm<sup>3</sup> or 250 cm<sup>3</sup> conical flask, labelled **X**, with one-hole bung connected to approximately 50 cm of plastic/rubber delivery tube. **The Supervisor and all the candidates should use the same size conical flask.**

 2 × teat/dropping pipette  
 1 × spatula  
 1 × Bunsen burner  
 1 × heat-proof mat  
 1 × test-tube holder  
 1 × boiling tube  
 1 × hard-glass test-tube  
 6 × test-tube\*  
 1 × test-tube rack  
 balance, single-pan, direct reading, minimum accuracy 0.01 g (1 per 8–12 candidates) weighing to 200 g  
 1 × wash bottle containing distilled water  
 1 × pen for labelling glassware  
 paper towels  
 red and blue litmus papers  
 aluminium foil  
 wooden splints  
 the apparatus normally used in the centre for use with limewater in testing for carbon dioxide

\*Candidates are expected to rinse and reuse test-tubes where possible.  
 Additional test-tubes should be available.

## Materials

The materials listed in the table must be provided to each candidate. **Materials must be labelled only as specified in the ‘label’ column. The identities of chemicals labelled with letter codes, e.g. FA 1, may be different from their descriptions in the question paper. Candidates must use the descriptions given in the question paper. For example, candidates may be supplied with sulfuric acid, labelled as FA 1, but be told in the question paper that FA 1 is phosphoric acid.**

<b>FA 1</b>	0.7 g	calcium carbonate	Provide $0.70 \pm 0.1$ g powdered $\text{CaCO}_3$ in a stoppered container.
<b>FA 2</b>	$70 \text{ cm}^3$	$0.500 \text{ mol dm}^{-3}$ hydrochloric acid	Dilute $250 \text{ cm}^3$ of $2.0 \text{ mol dm}^{-3} \text{ HCl}$ in each $\text{dm}^3$ of solution. For $2.0 \text{ mol dm}^{-3} \text{ HCl}$ , see preparation instructions in the current syllabus.
<b>FA 3</b>	$40 \text{ cm}^3$	$0.500 \text{ mol dm}^{-3}$ hydrochloric acid	Same as <b>FA 2</b> .
<b>FA 5</b>	$100 \text{ cm}^3$	$0.0600 \text{ mol dm}^{-3}$ sodium hydroxide	Dissolve 2.4 g of $\text{NaOH}$ [C] in each $\text{dm}^3$ of solution. <b>A different concentration is given in the question paper.</b>
<b>FA 6</b> [F][MH][HH]	$5 \text{ cm}^3$	bromophenol blue indicator	See preparation instructions in the current syllabus.
<b>FA 7</b>	$20 \text{ cm}^3$	solution of copper(II) chloride and ammonium chloride	Dissolve $10.0 \text{ g CuCl}_2 \cdot 2\text{H}_2\text{O}$ [MH][N] and $6.0 \text{ g NH}_4\text{Cl}$ [MH] in each $\text{dm}^3$ of solution.
<b>FA 8</b>	1.0 g	sodium hydrogen carbonate	Provide $1.0 \pm 0.1$ g $\text{NaHCO}_3$ in a stoppered container.
<b>FA 9</b> [MH]	1.0 g	anhydrous sodium carbonate	Provide $1.0 \pm 0.1$ g $\text{Na}_2\text{CO}_3$ [MH] in a stoppered container.
<b>distilled water</b>	$250 \text{ cm}^3$	distilled water	
<b>aqueous potassium iodide</b>	$5 \text{ cm}^3$	$0.1 \text{ mol dm}^{-3}$ potassium iodide	Dissolve 16.6 g KI in each $\text{dm}^3$ of solution.
<b>starch solution</b>	$5 \text{ cm}^3$	freshly prepared aqueous starch solution (approx 2% solution w/v)	See preparation instructions in the current syllabus.

dilute hydrochloric acid	10 cm <sup>3</sup>	2.0 mol dm <sup>-3</sup> $\text{HCl}$	
dilute nitric acid [C]	10 cm <sup>3</sup>	2.0 mol dm <sup>-3</sup> $\text{HNO}_3$	
dilute sulfuric acid [MH]	10 cm <sup>3</sup>	1.0 mol dm <sup>-3</sup> $\text{H}_2\text{SO}_4$	See preparation instructions in the current syllabus.
aqueous ammonia [C][MH][N]	10 cm <sup>3</sup>	2.0 mol dm <sup>-3</sup> $\text{NH}_3$	If necessary, each of these reagents can be provided as a communal supply for groups of up to 6 candidates.
aqueous sodium hydroxide [C]	10 cm <sup>3</sup>	2.0 mol dm <sup>-3</sup> NaOH	Invigilators must be alert to the risk of contamination and the opportunity for malpractice when using a communal supply.
aqueous barium chloride or aqueous barium nitrate	10 cm <sup>3</sup>	0.1 mol dm <sup>-3</sup> $\text{BaCl}_2$ or 0.1 mol dm <sup>-3</sup> $\text{Ba}(\text{NO}_3)_2$	
limewater [MH]	10 cm <sup>3</sup>	saturated aqueous calcium hydroxide, $\text{Ca}(\text{OH})_2$	
aqueous silver nitrate	10 cm <sup>3</sup>	0.05 mol dm <sup>-3</sup> $\text{AgNO}_3$	
acidified aqueous potassium manganate(VII) [MH]	10 cm <sup>3</sup>	0.01 mol dm <sup>-3</sup> $\text{KMnO}_4$ in 0.5 mol dm <sup>-3</sup> $\text{H}_2\text{SO}_4$
