**Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

**GENERIC MARKING PRINCIPLE 1:**

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

**GENERIC MARKING PRINCIPLE 2:**

Marks awarded are always **whole marks** (not half marks, or other fractions).

**GENERIC MARKING PRINCIPLE 3:**

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit is given for valid answers which go beyond the scope of the syllabus and mark scheme, referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

**GENERIC MARKING PRINCIPLE 4:**

Rules must be applied consistently, e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

**GENERIC MARKING PRINCIPLE 5:**

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

**GENERIC MARKING PRINCIPLE 6:**

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

2(a)(i)	<b>1 mark</b> for each correct term.  Random Access Memory (RAM) and Read Only Memory (ROM) are both examples of <b>primary</b> memory.  One item that is stored in RAM is <b>currently running software/data/part of OS</b> .  One item that is stored in ROM is <b>the start-up/boot-up instructions/BIOS</b> .  RAM can be either Static RAM (SRAM) or Dynamic RAM (DRAM). SRAM uses transistors arranged as <b>flip-flops/latches</b> . DRAM uses transistors and <b>capacitors</b> .	<b>5</b>
2(a)(ii)	<b>1 mark</b> per bullet point to max 3  <ul style="list-style-type: none"> <li>PROM can be set once, EPROM and EEPROM can be overwritten multiple times.</li> <li>EPROM needs to be removed from device EEPROM can be erased in situ.</li> <li>EPROM and can be erased using UV light, EEPROM can be erased using voltage // is flash storage .</li> <li>EPROM must be entirely erased before rewriting, EEPROM does not have to be entirely erased before rewriting.</li> </ul>	<b>3</b>

2(b)	<p><b>1 mark</b> per bullet point to <b>max 5</b></p> <ul style="list-style-type: none"> <li>• The hard disk has (one or more) platter/plate/disk</li> <li>• Each surface of the platter/disk is (ferrous oxide which is) capable of being magnetised</li> <li>• The platters/disks are mounted on a (central) spindle</li> <li>• The entire mechanism is contained inside a sealed (aluminium) box.</li> <li>• The disks are rotated (at high-speed)</li> <li>• (Each surface of the disk) has a read/write head mounted on an arm (positioned just above the surface)</li> <li>• Electronic circuits control the movement of the arm (and hence the heads)</li> <li>• The surface of the platter/disk is divided into <u>concentric</u> tracks / circles</li> <li>• The surface of the platter/disk is divided into sectors</li> <li>• One track in one sector is the basic unit of storage called a block</li> <li>• The data is encoded as a magnetic pattern for each block</li> <li>• When writing to disk, a variation in the current in the head produces a variation in magnetic field on the disk</li> <li>• When reading from disk, a variation in magnetic field produces a variation in current through the head</li> </ul>	<b>5</b>

5(c)	<p><b>1 mark</b> per bullet point to <b>max 3</b></p> <ul style="list-style-type: none"> <li>• Saves (programming/testing) time as code does not have to be written/re-written from scratch // code does not have to be tested</li> <li>• Code is already tested so it is more robust/likely to work</li> <li>• If there is an improvement in the library routine the program updates automatically</li> <li>• can perform complex calculations that the programmer may be unable to do</li> </ul>	<b>3</b>

6(a)(i)	<p><b>1 mark</b> per bullet point to <b>max 5</b></p> <ul style="list-style-type: none"> <li>• The Program Counter (PC) holds the <b>address</b> of the next instruction ...</li> <li>• ...and the <b>contents</b> are incremented / changed to the next address each cycle</li> <li>• The Memory Address Register (MAR) holds the address to fetch the data (from the PC)</li> <li>• The Memory Data Register (MDR) holds the data at the address in MAR</li> <li>• The instruction is transferred to Current Instruction Register (CIR) for decoding and execution</li> </ul>	<b>5</b>
6(a)(ii)	<p><b>1 mark</b> for detection</p> <ul style="list-style-type: none"> <li>• At the start/end of a FE cycle</li> </ul> <p><b>1 mark</b> for handling to <b>max 4</b></p> <ul style="list-style-type: none"> <li>• Priority is checked</li> <li>• If lower priority than current process continue with F-E cycle</li> <li>• If higher priority than current process ...</li> <li>• ... state of current process is / registers are stored on stack</li> <li>• Location / type of interrupt identified...</li> <li>• ...appropriate ISR is called to handle the interrupt</li> <li>• When ISR finished, check for further interrupts (of high priority) / return to step 1</li> <li>• Otherwise load data from stack and continue with process</li> </ul>	<b>5</b>
