### Production, location and change

If answering this option, answer Question 1 and **either** Question 2 **or** Question 3.

- 1 Table 1.1 shows the share of agricultural land used for organic production and the consumption of organic produce per capita, for world regions, in 2017.
  - (a) Compare the share of agricultural land used for organic production with the consumption of organic produce per capita for the world regions shown in Table 1.1. [4]
  - (b) Explain how **two** social factors influence agricultural land use and practices on farms. [6]
- 2 'Agricultural productivity in intensive systems is always greater than in extensive systems.'  
With reference to one or more examples, how far do you agree? [20]
- 3 With reference to **one** country's management of change in manufacturing industry, assess the relative importance of the issues faced. [20]

### Environmental management

If answering this option, answer Question 4 and **either** Question 5 **or** Question 6.

- 4 Fig. 4.1 shows the proportion of Key Biodiversity Areas (KBAs) covered by protected area status, by level of development, 1970–2020.
  - (a) Describe the trends shown in Fig. 4.1. [4]
  - (b) Explain **two** constraints on improving the quality of degraded environments. [6]
- 5 Evaluate the extent to which energy consumption by MICs has become a global issue. [20]
- 6 Evaluate the extent to which urbanisation is the main factor in the degradation of urban environments. [20]

## Global interdependence

If answering this option, answer Question 7 and **either** Question 8 **or** Question 9.

- 7 Fig. 7.1 shows the number of Fairtrade farmers and workers, and total production of selected Fairtrade products, in 2016.
- (a) Describe the relationship shown in Fig. 7.1. [4]
- (b) Explain the positive impacts of Fairtrade for countries which export primary products. [6]
- 8 'International aid benefits the donor country more than the receiving country.'
- With reference to one or more examples, how far do you agree? [20]
- 9 With reference to one or more examples, to what extent is an understanding of carrying capacity helpful in evaluating the impact of tourism on a destination? [20]

## Economic transition

If answering this option, answer Question 10 and **either** Question 11 **or** Question 12.

- 10 Fig. 10.1 shows satellite images of two areas in the city of Rio de Janeiro, Brazil, an MIC in South America.
- (a) Identify evidence from the satellite images which suggests there is social inequality between the two areas shown in Fig. 10.1. [4]
- (b) Explain how **two** measures or indices are used to show economic inequality. [6]
- 11 With reference to **one** transnational corporation (TNC), evaluate the factors which influence its global spatial organisation and operation. [20]
- 12 With reference to **one** country, evaluate the success of attempted solutions to overcome its regional disparities. [20]
