This mark scheme contains the instructions and marking guidance that our examiners used to mark candidate responses for this component.

Before they start marking, examiners complete a standardisation process. They review a range of candidate responses and discuss the mark scheme in detail to agree which answers can and cannot be accepted. Examiners award marks where it is clear that candidate responses have met the requirements of the mark scheme. These requirements may vary between different components or different versions of the same component, depending on the exact requirements of the question and the candidate responses seen during the standardisation process.

Sometimes, our mark schemes may allow marks to be awarded to responses which contain elements that are factually incorrect or for content not covered by the syllabus. We do this in response to the demands of a specific question to support candidates and make sure that our assessments are fair. However, these allowances should not be used as a guide for teaching and learning.

We cannot discuss the mark scheme with schools, and we recommend that schools read the mark scheme together with the assessment material and the Principal Examiner Report for Teachers.

General marking principles

All examiners must apply these marking principles when marking candidate responses.

1	Examiners must award marks for each response in line with: - the specific content defined in the mark scheme - the specific skills defined in the mark scheme or in the level descriptions - the standard of response required as exemplified by the standardisation scripts.
2	Examiners must award whole marks (not half marks, or other fractions).
3	Examiners must award marks positively . This means that: - marks are not deducted for errors or omissions - marks are awarded for correct/valid answers as defined in the mark scheme and also for other valid answers which go beyond the scope of the syllabus and mark scheme referring to your team leader as appropriate - the quality of spelling, punctuation and grammar are judged only when the mark scheme indicates that these features are specifically assessed in the question. However, the meaning of all responses must be unambiguous.
4	Examiners must consistently apply the requirements of the mark scheme and any rules for what to do when candidates have not followed instructions correctly.
5	Examiners must use the full range of marks defined in the mark scheme, unless limited by the quality of the candidate responses seen.
6	Examiners must award marks according to the mark scheme and must not award marks with grade thresholds or grade descriptions in mind.

Annotations guidance for centres

Examiners use a system of annotations as a shorthand for communicating their marking decisions to one another. Examiners are trained during the standardisation process on how and when to use annotations. The purpose of annotations is to inform the standardisation and monitoring processes and guide the supervising examiners when they are checking the work of examiners within their team. The meaning of annotations and how they are used is specific to each component and is understood by all examiners who mark the component.

We publish annotations in our mark schemes to help centres understand the annotations they may see on copies of scripts. Note that there may not be a direct correlation between the number of annotations on a script and the mark awarded. Similarly, the use of an annotation may not be an indication of the quality of the response.

General levels of response

Process for awarding marks:

- Markers review the answer against the AO4 marking criteria, and award a mark according to these criteria.
- Generally, the subsequent mark awarded for AO1 will be the same level. In exceptional cases, markers could award marks in different levels for the two AOs. This is because the ability to recall, select and deploy relevant historical material will be central to any effective analysis and evaluation of the interpretation.
- Responses that focus on contextual knowledge without reference to the interpretation cannot be rewarded.

Underlining is used in this mark scheme to indicate the main interpretation of the extracts.

1	The Origins of the First World War Interpretation/Approach The main interpretation is <u>that the historian blames Austria and Germany for preferring war to peace because (i) both had more to gain from war and (ii) much to lose from peace.</u> Showing complete understanding of the interpretation will involve discussion of both these aspects for both countries. This is an interpretation that sees both Germany and Austria as welcoming war, which had the potential to resolve the problems that both faced. The Austrians might have assumed that war could be contained in the Balkans, but the Germans sought to deal with the Dual Alliance whilst it had the chance. Both knew defeat could be a catastrophe, but risked war all the same. <u>Glossary:</u> Early post-WW1 interpretations tended to blame Germany, but quickly a reaction against this occurred, with a variety of interpretations blaming other nations. This may be termed revisionism. The turning point in the historiography was Fischer's work of the early 1960s which went back to blaming Germany – sometimes known as anti-revisionism. Since then, there has been a vast variety of interpretations, looking at the importance of culture, individuals, contingent factors etc., with no clear consensus, though most historians would still place a significant burden of responsibility on Germany.	40

2	The Holocaust Interpretation/Approach The main interpretation is <u>that the Holocaust came about because (i) the mass murder of Jewish and non-Jewish people was intended in the war against the Soviet Union and (ii) that Operation Barbarossa marked the shift from a broadly genocidal policy to the Final Solution</u> Showing complete understanding of the Interpretation will involve discussion of both these aspects. This is an interpretation that sees the Barbarossa plans for dealing with the Jews as still vague and imprecise, and although Soviet Jews would undoubtedly die in huge numbers, and eventually be wiped out, exactly how this would happen remained unspecified. Only after the first phases of the attack on the Soviet Union did the plans for the Final Solution – the murder of all Jews – gradually appear. Because the interpretation sees Barbarossa as including plans to murder large numbers of Jews, many candidates will see the historian's approach as intentionalist, which could reach L5/L6. However, the implication that the Final Solution was consequential on Barbarossa might produce answers that detect functionalism. How this is argued is crucial in determining the level awarded, though if the intentionalist aspect is ignored, such answers could go beyond L5. <u>Glossary:</u> Candidates may use some/all of the following terms: <i>Intentionalism</i> – interpretations which assume that Hitler/the Nazis planned to exterminate the Jews from the start. <i>Structuralism</i> – interpretations which argue that it was the nature of the Nazi state that produced genocide. There was no coherent plan but the chaotic competition for Hitler's approval between different elements of the leadership produced a situation in which genocide could occur. <i>Functionalism</i> sees the Holocaust as an unplanned, ad hoc response to wartime developments in Eastern Europe, when Germany conquered areas with large Jewish populations. Candidates may also refer to <i>synthesis</i> interpretations, i.e. interpretations which show characteristics of more than one of the above. What counts is how appropriate the use of this kind of terminology is in relation to the extract, and how effectively the extract can be used to support it.	40

Question	Answer	Marks
3	The origins and development of the Cold War Interpretation/Approach The main interpretation is <u>that the historian blames (i) Stalin for pursuing an unlimited expansionist policy which alarmed other countries (ii) which then sought to involve the USA as a counterweight to the Soviet threat.</u> Showing complete understanding of the Interpretation will involve discussion of both these aspects. The historian indicates that the Soviet threat was seen as real and served to alienate the USA and its allies and convince them that cooperation with the Russians would not be possible. In blaming Stalin/the Soviets, along with reference to a new generation of historians, the historian's approach may be seen as post-post-revisionist, though there is little on Stalin's personality and no real focus on ideology. However, the lack of exoneration of the USA makes post-post-rev more plausible than traditional. Answers which argue traditional / orthodox can reach L5. <u>Glossary:</u> <i>Traditional/Orthodox</i> interpretations of the Cold War were generally produced early after WW2. They blame the Soviet Union and Stalin's expansionism for the Cold War. <i>Revisionist</i> historians challenged this view and shifted more of the focus onto the United States, generally through an economic approach which stressed the alleged aim of the US to establish its economic dominance over Europe. <i>Post-revisionists</i> moved towards a more balanced view in which elements of blame were attached to both sides. Since the opening of the Soviet archives post-1990 there has been a shift to attributing prime responsibility to Stalin – a <i>post-post-revisionist</i> stance which often seems very close to the traditional view, but which often places great importance on ideology. What counts is how appropriate the use of this kind of terminology is in relation to the extract, and how effectively the extract can be used to support it.	40
