General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
 - the scripts of the candidates specified on the bar code label provided
 - the supervisor's results relevant to these candidates
 - the supervisor's reports relevant to these candidates
 - seating plans for each practical session, referring to each candidate by candidate number
 - the attendance register.

Specific information for this practical exam

The supervisor must be a teacher of physics or other competent physicist who is familiar with the requirements of this syllabus. During the exam, the supervisor (**not** the invigilator) should obtain a sample set of numerical results by following the relevant steps in the question paper. The results should be clearly labelled 'supervisor's results' and recorded on the supervisor's report or on a spare copy of the question paper.

Organisation of the exam

- The number of sets of apparatus provided for each experiment should be $\frac{1}{2}N$, where N is the number of candidates taking the exam.
- Candidates must **not** be provided with any additional apparatus beyond that specified in these instructions.
- Candidates should be allowed access to the apparatus for each experiment for one hour only.
- After spending one hour on one experiment, candidates should change over to the other experiment.
- The order in which a candidate attempts the two experiments is immaterial.

Assistance to candidates

- Candidates should be informed that, if they find themselves in real difficulty, they may ask the supervisor for practical assistance, but that the extent of this assistance will be reported to the examiner, who may not award full credit for the relevant skills.
- Assistance should only be given when it is asked for by a candidate or where apparatus is seen to have developed a fault.
- Assistance should be restricted to enabling candidates to make observations and measurements. Observations and measurements must **not** be made for candidates, and no help should be given with data analysis or evaluation.
- In cases of faulty apparatus that prevent the required measurements from being taken, the supervisor should allow extra time to give the candidate a fair opportunity to perform the experiment as if the fault had not been present.
- Any assistance or extra time given to candidates must be recorded in the supervisor's report.

Materials and apparatus for Question 1 (per set of apparatus unless otherwise specified)

- Stand with height at least 60 cm. See Note 1.
- Boss.
- Clamp.
- Metre rule with a millimetre scale.
- 30 cm ruler with a millimetre scale.
- String of approximate diameter 1 mm. See Note 2.
- Expendable spring with approximate outside diameter 15 mm, approximate coiled length 20 mm and approximate spring constant 25 N m^{-1} (e.g. Philip Harris product code B8A41397). See Note 2.
- Wooden strip of approximate length 40 cm, approximate width 4 cm and approximate thickness 5 mm. See Note 3.
- Screw of approximate length 2 cm. See Note 3.
- 10 g mass hanger with its mass value clearly shown.
- Five 10 g slotted masses with their mass values clearly shown.
- Approximately 6 g of adhesive putty.
- Wooden block with approximate dimensions 5 cm \times 5 cm \times 5 cm. See Note 4.
- 180° protractor with 1° divisions. See Note 4.
- Ten paper clips, each of approximate length 3 cm.
- Small container for the adhesive putty and paper clips.
- Access to a balance reading to 0.1 g or better (shared between, at most, four candidates).

Notes

1 If the base of the stand is triangular, then the base should be fixed to a small square wooden or plastic board with approximate thickness 1 cm, as shown in Fig. 1.1.






Fig. 1.2 (not to scale)

2 The spring should be attached to a string of approximate length 50 cm with loops of approximate circumference 6 cm at each end, as shown in Fig. 1.2.

The spring should be gently extended and released several times by approximately 20 cm.




Fig. 1.3 (not to scale)

Set up the stand, boss, clamp, spring and string as shown in Fig. 1.3.




Fig. 1.4 (not to scale)

3 The screw should be fixed centrally in the wooden strip approximately 1 cm from one end, as shown in Fig. 1.4.

4 Attach the protractor to the wooden block with approximately two-thirds of the adhesive putty, as shown in Fig. 1.5.



The remainder of the adhesive putty should be placed in the small container.

5 The apparatus should be laid out on the bench. If the apparatus is to be used by another candidate, then it should be restored to its original state. A new set of paper clips should be provided and any adhesive putty attached to the apparatus by the candidate should be returned to the small container.

Materials and apparatus for Question 2 (per set of apparatus unless otherwise specified)

- Strip of hardboard of approximate length 150 cm, approximate width 7 cm and thickness 2–3 mm. See Note 1.
- Two stands, each of height at least 60 cm.
- Two bosses.
- Two clamps.
- 100 g mass hanger with its mass value clearly shown.
- Expendable spring with approximate outside diameter 15 mm, approximate coiled length 20 mm and approximate spring constant 25 N m^{-1} (e.g. Philip Harris product code B8A41397).
- Stop-watch reading to 0.1 s or better.
- Metre rule with a millimetre scale.

Notes




Fig. 2.1 (not to scale)

1 Using a drill bit of diameter 10 mm, drill two holes centrally in the hardboard. Each hole should be approximately 6 cm from the end of the board, as shown in Fig. 2.1.

2 The apparatus should be laid out on the bench. If the apparatus is to be used by another candidate, then it should be restored to its original state.
