| 4(c)(i) | In Piggyback, History and Geography must have been her "double" and "piggyback" categories (to be able to add more than $\$ 50$ to her prize pot). She must have answered 8 questions correctly in one of the two categories and not taken part in the other. Her total number of correct answers in Piggyback was therefore $8+8+7+9=32$. $32(\text { in Piggyback })+5(\text { in Freeze })+12(\text { in Multiplier })=\underline{49}$ <br> If 2 marks cannot be awarded, award 1 mark for evidence of appreciation that she answered 32 questions correctly in Piggyback <br> OR for an answer of 57 (counting piggyback answers as her own) | 2 |
| 4(c)(ii) | Her prize pot after the ninth Freeze question was $\$ 365$, then $\$ 325$ after she did not attempt the last question.
