- (b) Describe the procedure in the study by Sensky et al. (2000) of cognitive-behavioural therapy (CBT) for schizophrenia. [4]
- (c) Explain **one** similarity and **one** difference between CBT and biochemical treatments for schizophrenia/delusional disorder. [6]
- 2 (a) Describe characteristics and measures of bipolar and related disorders. [8]
- (b) Evaluate characteristics and measures of bipolar and related disorders, including a discussion of validity. [10]

- 4 (a) Describe what psychologists have discovered about lighting, colour and smell in the physical environment. [8]
- (b) Evaluate what psychologists have discovered about lighting, colour and smell in the physical environment, including a discussion about control of variables. [10]

- (b) Describe the study by Lau et al. (1990) on health change in adolescents. [4]

- (b) Evaluate what psychologists have discovered about measuring pain, including a discussion of psychometrics. [10]

- 8 (a) Describe what psychologists have discovered about group development and roles in organisations. [8]
- (b) Evaluate what psychologists have discovered about group development and roles in organisations, including a discussion of practical applications. [10]
