### Section A: Education

Answer **either** Question 1 **or** Question 2.

- 1 (a) Explain how the educational performance of girls may be influenced by the hidden curriculum. [9]
- (b) 'The education system works against the interests of working-class pupils.' Assess this view. [16]
- 2 (a) Explain how teachers may influence which pupils succeed in education. [9]
- (b) 'Gender is more important than ethnicity in determining levels of educational achievement.' Assess this view. [16]

### Section B: Global Development

Answer **either** Question 3 **or** Question 4.

- 3 (a) Explain how differences in levels of development can be measured. [9]
- (b) 'Overpopulation is the main cause of poverty in developing countries.' Assess this view. [16]
- 4 (a) Explain how development may be affected by colonialism. [9]
- (b) 'All societies are moving towards the same development stage.' Assess this view. [16]

### Section C: Media

Answer **either** Question 5 **or** Question 6.

- 5 (a) Explain the Marxist view of the relationship between ownership and control of the media. [9]
- (b) 'The media control how information is received and interpreted by audiences.' Assess this view. [16]
- 6 (a) Explain the factors influencing how news is reported. [9]
- (b) 'The new media have brought about a transfer of power from large organisations to the individual citizen.' Assess this view. [16]

**Section D: Religion**

Answer **either** Question 7 **or** Question 8.

- 7 (a) Explain why the growth of new religious movements may be seen as evidence of secularisation. [9]
- (b) 'Religious movements are increasingly seeking to bring about social change.' Assess this view. [16]
- 8 (a) Explain how cults differ from other types of religious organisation. [9]
- (b) 'The extent to which desacrilisation has occurred in modern industrial societies has been exaggerated.' Assess this view. [16]
