General information about practical exams

Centres must follow the guidance on science practical exams given in the Cambridge Handbook.

Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor must perform the experiments and record the results as instructed.
 This must be done out of sight of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

After the exam

Specific information for this practical exam

Question 1

Each candidate should be provided with:

	suitable eye protection	1

Preparation of materials

agar containing universal indicator

Sprinkle 1.5g of non-nutrient or technical agar onto 100 cm³ of distilled water in a beaker, heat gently until the mixture clears. When the mixture is clear, remove from the heat source and add 1 cm³ of universal indicator **[F]** to obtain a green or blue-green colour. If the colour is red or orange, add drops of 1 mol dm⁻³ sodium hydroxide solution **[C]** until a blue-green colour is obtained. Pour the molten agar into a heat-proof container to a depth of 1 cm.

When the agar is set it should be cut into $4 \, \text{cm} \times 4 \, \text{cm} \times 1 \, \text{cm}$ pieces and presented to candidates on a white tile.
