General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:

Specific information for this practical exam

Question 1

Each candidate should be provided with:

Preparation of materials

potato and apple cylinders

White potatoes (*Solanum tuberosum*) and any variety of cooking or eating apples (*Malus domestica*) are suitable. Cylinders of potato and apple should be cut with a cork borer. Remove any outer peel or skin from the cylinders. A cork borer with diameter of 8–10 mm is suitable. Each cylinder must have a length greater than 2 cm. The apple cylinder should be presented in a Petri dish labelled **apple**. The potato cylinder should be presented in a Petri dish labelled **potato**. Cover both cylinders with a damp paper towel.

3% hydrogen peroxide solution

This should be made from a fresh stock solution **[C]** as close to the time of the exam as possible.
