## General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

### During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

### After the exam

## Specific information for this practical exam

### Question 1

Each candidate should be provided with:

	ruler with a mm scale (also needed for Question 2)	1
	stop-clock	1
	permanent marker pen	1
	paper towels	5
	suitable eye protection	1
	gloves	1 pair

## Preparation of materials

### *potato extract*

Cut 100g of peeled white potato (*Solanum tuberosum*) into pieces. Put the potato pieces in a blender and add 100cm<sup>3</sup> of water. Blend until homogenised. A mortar and pestle could be used instead of a blender. Filter the potato mixture through muslin cloth. The potato extract can be prepared the day before the exam as the filtering process may take some time. It can then be stored in a refrigerator until needed. Allow the potato extract to reach room temperature before presenting to candidates on the day of the exam.
