## General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

### Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

### During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the bar code label provided
  - the supervisor's results relevant to these candidates
  - the supervisor's reports relevant to these candidates

## Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do the experiment in Question 1 and record the results on a spare copy of the question paper, clearly labelled “supervisor’s results”.

### Question 1

Each candidate should be provided with:

	1.0% starch suspension, in a beaker labelled <b>starch</b>	20 cm <sup>3</sup>
	distilled water, in a beaker labelled <b>distilled water</b>	100 cm <sup>3</sup>
	clean dry white tile, 15 cm × 15 cm	1
	iodine solution in a bottle labelled <b>iodine solution</b> with a dropper	20 cm <sup>3</sup>
	tap water in a container labelled <b>water for washing</b>	200 cm <sup>3</sup>
	empty container labelled <b>waste</b>	1
	10 cm <sup>3</sup> syringe	1
	2 cm <sup>3</sup> syringe	2
	Pasteur pipettes	4
	small beakers or specimen tubes to hold 10 cm <sup>3</sup> of liquid	4
	standard test-tubes	5
	test-tube rack, to hold at least 5 test-tubes	1
	permanent marker pen	1
	stop-clock	1
	paper towels	5
	suitable eye protection	1
	gloves	1 pair

## Preparation of materials

**[MH] [HH] [C]** *2.0% amylase solution*

This is prepared by putting 2.0g of bacterial amylase, **[HH] [MH] [C]** into 80cm<sup>3</sup> of distilled water and mixing until dissolved. Make up to 100 cm<sup>3</sup> with distilled water. This should be prepared on the day of the exam.

*seed extract U*

**[MH] [HH] [C]** This is prepared by putting 1.5g of bacterial amylase, **[HH] [MH] [C]** into 80cm<sup>3</sup> of distilled water and mixing until dissolved. Make up to 100 cm<sup>3</sup> with distilled water. This should be prepared on the day of the exam.

*1.0% starch suspension*

This is prepared by mixing 1g of soluble starch with a few drops of distilled water to make a paste. Gradually add 80cm<sup>3</sup> of distilled water and heat until the liquid clears. Make up to 100 cm<sup>3</sup> with distilled water. Allow the solution to cool.

*iodine solution*

A commercially prepared iodine solution suitable for standard food tests can be used.

## Question 2

Each candidate should be provided with:
