## General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

### Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

The following hazard codes are used in these confidential instructions, where relevant:

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

### During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the bar code label provided
  - the supervisor's results relevant to these candidates
  - the supervisor's reports relevant to these candidates
  - seating plans for each practical session, referring to each candidate by candidate number

## Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do the experiment in Question 1 and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

### Question 1

Each candidate should be provided with:

	25 cm <sup>3</sup> or 50 cm <sup>3</sup> measuring cylinder	1
	large test-tubes (approximately 150 mm × 25 mm)	2
	test-tube rack to hold two large test-tubes	1
	250 cm <sup>3</sup> beaker containing 100 cm <sup>3</sup> (without foam) of active yeast suspension, labelled <b>yeast suspension</b>	1
	glass rod	1
	round-shaped, rubber or latex, balloons of the same size	2
	30 cm long piece of string	1
	30 cm ruler with a mm scale (also needed for Question 2)	1
	empty 250 cm <sup>3</sup> beaker	1
	250 cm <sup>3</sup> beaker containing 200 cm <sup>3</sup> of tap water at room temperature, labelled <b>cold water-bath</b>	1
	supply of hot water at approximately 60 °C Candidates will raise their hand when they are ready for the hot water.	approximately 200 cm <sup>3</sup>
	thermometer, -10 to +110 °C at 1 °C graduations	1
	stop-clock	1
	permanent marker pen	1
	paper towels	5
	gloves	1 pair
	suitable eye protection	1

**Preparation of materials***yeast suspension*

This should be freshly prepared just before the exam. Put 50 g of fast-acting yeast and 10 g of sucrose (table sugar) into enough warm water to make up to 1 dm<sup>3</sup>. Ensure that the yeast suspension is active and producing foam. Remove and discard the foam from the top of the suspension and stir the suspension before pouring it into the beakers for candidates.

*balloons*

Standard round rubber or latex party balloons are suitable. Foil balloons are not suitable. The balloons should be easy to inflate without the use of a pump. The neck of the balloon should be wide enough so that it can easily be stretched over the opening of a large test-tube.
