## General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

### Safety

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

### During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the bar code label provided
  - the supervisor's results relevant to these candidates

## Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do the experiment in Question 1 and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

### Question 1

Each candidate should be provided with:

	10 cm <sup>3</sup> syringe	1
	insoluble modelling clay, plasticine or similar	10g
	beaker containing yeast suspension, without foam, labelled <b>yeast suspension</b>	30 cm <sup>3</sup>
	250 cm <sup>3</sup> measuring cylinder	1
	supply of hot water at approximately 50 °C Candidates will raise their hand when they require hot water. This should be poured directly into their measuring cylinder.	approximately 120 cm <sup>3</sup>
	a supply of cold water at approximately 20 °C, in a suitable container labelled <b>cold water</b>	200 cm <sup>3</sup>
	waste container to hold at least 250 cm <sup>3</sup> of liquid, labelled <b>waste</b>	1
	thermometer, –10 °C to +110 °C, with 1 °C graduations	1
	glass rod	1
	stop-clock	1
	paper towels	5
	gloves	1 pair
	suitable eye protection	1

### Question 2

Each candidate should be provided with:

hazard	materials and apparatus	quantity per candidate
	30 cm ruler with a mm scale	1

**Preparation of materials***yeast suspension*

Put 50g of fast-acting yeast and 5g of sucrose (table sugar is suitable) into enough warm water to make up to 1 dm<sup>3</sup>. Ensure that the yeast is active and respiring and remove the foam before presenting to candidates.
