### Source 1

They are more motivated and create more products. Our profits are higher and we have increased the number of employees by 15 per cent.

I won an environmental award from the government and was on television. We are proud of our achievement and now advise other businesses on how to reduce their use of fossil fuels.

### Paolo (a government representative)

Next week we will be sending you a leaflet describing our plans. You will all have access to a cheaper and more reliable form of energy. Your community will be able to see the advantages, for example you will be able to swim in the reservoir.

Farmers and landowners will make money when we buy land near the dam. Farms will be moved to another area. We will support wildlife habitats.

We hope that you will support our plans and contribute to a greener future.

### Adriana (a village representative)

My family lives near the river where you want to build the dam. There are nine small fishing communities that will disappear under the water.

We all depend on the fish in the river for our livelihood. We catch enough fish to sell at the local market. Sometimes we hunt animals in the nearby forests. The money we earn at the market allows us to pay our bills. The villagers nearby are all angry about this new scheme. I do not think you know anything about how we live. The dam will be a disaster for us!

My grandfather has fished here for 45 years. He says this is part of our heritage and is sacred to our ancestors. Please can the government respect our history and way of life? We don't want to move. Where would we live?

You say you will look after wildlife, but you have told us nothing about how this will happen. How can we believe you? We know we need cleaner energy but this is not the way to do it. Why can't you build wind farms out in the ocean where people don't live?
