Task 1 – Evidence Document

Open the file **J2222EVIDENCE.rtf**

Task 2 – Document

You are going to edit a document for Tawara Adriatic Marine. The company uses a corporate house style for all their documents. Paragraph styles must be created, modified and applied as instructed.

1 Open the file **J2222GUIDE.rtf**

The page setup is set to A4, portrait orientation with 2 centimetre margins. Do **not** make any changes to these settings.

Three paragraph styles have already been created. Do **not** make any changes to these unless instructed.

Save the document in your work area, in the format of the software you are using, with the file name **TAM_Marinas**

Take a screenshot to show this file has been saved including evidence of the file type. Place this screenshot in your Evidence Document.

The *TAM-subtitle* paragraph style has already been created and applied to the subtitle text.

Modify the *TAM-subtitle* paragraph style so only the following formatting is applied:

- 7 Select the subheading *The Adriatic* and the following text up to and including the paragraph ending ... *price list for each marina*.

Change the page layout so that only this text is displayed in two columns of equal width with a 2 centimetre space between them.

- 8 Apply arrow (➤) shaped bullets to the text from

boat repair ...

to

... and showering facilities.

Make sure that:

- the bullets are indented 1 centimetre from the left margin
- the list is in single line spacing with no space before or after each line
- there is a 6 point space after the last item in the list.

- 9 Identify the five subheadings in the document and apply the *TAM-subhead* paragraph style to each one.

- 10 Import the image **J2222ANCHOR.jpg** and place it in the paragraph beginning *During the summer months ...*

Crop the image to remove only the wave line below the anchor.

Format the cropped image so that:

- it is resized to a width of 3.5 centimetres with no distortion
- it is aligned to the left of the column and top of the paragraph starting *During the summer months ...*
- the text wraps around the image.

- 11 Locate the table in the document.

Apply the *TAM-table* paragraph style to the table.

- 12 Insert a new row as the first row of the table and enter the title:

Support Telephone Numbers

- 13 Format the first row of the table to be centre aligned over the two columns.

- 14 Format the table so that:

- all internal and external gridlines are displayed when printed
- the border and all data fit within the column width
- there is a 6 point space after the table.

Save the document using the same file name and format used in step 1.

Print the document.

You are now going to prepare some reports. Make sure all currency values display the same currency symbol and are set to 0 decimal places.

- 15 Using a suitable database package, import the file **J2222MARINA.csv**

Set *Marina_ID* as a primary key.

Save the data.

Import the file **J2222VESSELS.csv** as a new table in your database.

Use these field names and data types:

Do **not** set a primary key.

<i>Cabins</i>	8
<i>Marina</i>	JOS_ES
<i>Crewed</i>	No

Check your data entry for errors.

Save the data.

18 Using fields from both tables produce a tabular report that:

- selects only the records where:
 - *Yacht_Name* ends with the text star
 - *Language* is Greek or Spanish
 - *Crewed* is No
- contains a new field called **New_Rate** which is calculated at run-time. This field will calculate the *Berth_Fee* minus 15% of the *Berth_Fee*
- displays the *New_Rate* field as currency with 0 decimal places
- shows only the fields *Yacht_Name*, *Crewed*, *Length(m)*, *Beam(m)*, *Marina_Name*, *Sea*, *Country_Code*, *Language*, *Berth_Fee* and *New_Rate* in this order, with data and labels displayed in full. Do **not** group the data
- sorts the data into ascending order of *Country_Code* and descending order of *Length(m)*
- has a page orientation of landscape
- fits a single page wide and prints on two pages
- includes only the text **European Yachts Available** as a title displayed in a larger font size at the top of the page
- calculates the average *Berth_Fee* and places this at the end of the report, displayed as currency with 0 decimal places
- has a label **Average berth fee** to the left of this value
- displays only your name, centre number and candidate number in the footer so it appears in the same position on every page. Make sure no other data is displayed in the footer.

Save and print your report.

- sorts the data into ascending order of *Length(m)*

Save the extract.

Make sure that:

- the *TAM-table* paragraph style is applied to the extract
- the table fits within the column width
- all required fields and their labels are fully visible
- no text is wrapped within the extract
- there is a 6 point space after the table.

22 Spell check and proofread the document.

Make sure that:

- the list and tables are **not** split over columns or pages
- there are no widows or orphans
- there are no blank pages
- paragraph styles have been applied as instructed with consistent spacing maintained between all items
- there is a 6 point space after the tables and the list.

Save and print the document.

Task 5 – Mail merge

You are required to carry out a mail merge using a form.

- 23 Create a mail merge document using the file **J2222MOORING.rtf** as the master document and **J2222MDATA.csv** as your data source file.

Replace the text and chevrons in the master document with the merge fields from the data source file as follows:

27 Create a presentation of six slides using the file **J2222TOURISM.rtf**

Unless otherwise instructed, the slides must display a title and a bulleted list.

28 Use a master slide to display only the following features:

- a 3–4 point thick horizontal line across the width of the slide, about 3 centimetres from the top
- above the line enter the text **Support Coastal Tourism** in a large, black font, aligned to the top right of the slide. Make sure the text does **not** wrap
- automatic slide numbers on the bottom left
- your name, centre number and candidate number.

Make sure that:

- master slide items appear in the same position on every slide
- no items overlap on any slide.

29 Use the data in the file **J2222BOATS.csv** to create a vertical bar chart for only the top 5 ranked countries. This chart must display:

- the names of the countries on the category axis
- the values for 2022 only.

30 Label the chart as follows:

- chart title **Recreational Boats in Europe**
- value axis title **Thousands**
- category axis title **Country**

31 Display only the data values at the top of each bar.

32 Format the value axis scale to display:

- a minimum value of 0
- a maximum value of 1100
- increments of 100

33 Place the chart to the left of the bullets on the slide with the title *Participation*

Make sure that:

- no words in the chart are split
- all data and labels are fully visible
- no legend is displayed
- the chart and its content do **not** overlap any slide items.

34 Add the following text as presenter/speaker notes to the slide with the title *Participation*

Sweden and Finland have the most leisure boats

Print only this slide as presenter/speaker notes.

35 Save the presentation.

Print the presentation as a handout with 6 slides to the page.
