General information about practical exams

Centres must follow the guidance on science practical exams given in the Cambridge Handbook.

Safety

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor must perform the experiments and record the results as instructed.
 This must be done out of sight of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.

Specific information for this practical exam

During the exam, the supervisor (NOT the invigilator) must do the experiment in Question 1 and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

Question 1

Items to be supplied by the centre (per set of apparatus unless otherwise specified)

- (i) A block of wood with dimensions approximately $5 \, \text{cm} \times 4.5 \, \text{cm} \times 3 \, \text{cm}$. The wood must be able to float on water. See note 1.
- (ii) A dish of water at room temperature large enough for the block of wood to float on the water. See note 2.
- (iii) 30 cm or 50 cm ruler, graduated in mm.
- (iv) Electronic balance capable of measuring masses up to 100 g to the nearest gram. See note 3.
- (v) Paper towels to mop up any spilt water and to dry the block.

Notes

- 1. The block of wood must be dry and outside of the dish of water.
- **2.** The dish can be of any shape or material.
- 3. It is not necessary to provide a balance for each candidate but candidates must have convenient access to a balance without delay.

Action at changeover

Remove the block of wood from the dish. Dry the block of wood. Check that there is sufficient water in the dish. Replace the block if it has been marked.

Question 2

Items to be supplied by the centre (per set of apparatus unless otherwise specified)

- (i) Power supply of approximately 1.5–3 V. Where candidates are provided with a power supply with a variable output voltage, the voltage setting should be set by the supervisor and fixed (e.g. taped). See note 2.
- (ii) Resistor of nominal value 4.7Ω with a power rating of at least 2W. See note 3.
- (iii) A lamp in a suitable holder. Any low-voltage lamp will suffice, provided that it glows when connected in place of the resistor as shown in Fig. 2.1. See note 3.
- (iv) Switch. The switch may be an integral part of the power supply.
- (v) Ammeter capable of reading up to 1.00A with a minimum precision of 0.05A. See note 4.
- (vi) Voltmeter capable of measuring the supply p.d. with a minimum precision of 0.1 V. See note 4.
- (vii) Sufficient connecting leads to construct the circuit shown in Fig. 2.1, with two additional leads. See note 3.
- (viii) Spare lamps should be available.

Notes

1. The components are to be connected by the supervisor as shown in Fig. 2.1. The lamp is not to be connected into the circuit.



- 2. If cells are to be used, they must remain adequately charged throughout the examination. Spare cells should be available.
- 3. The value of resistance must not be visible to the candidates. The resistor and lamp must have suitable terminals so that candidates are able easily and quickly to rearrange the circuit.
- **4.** Either analogue or digital meters are suitable. Any variable settings should be set by the supervisor and fixed (e.g. taped). Spare meters should be available.

Action at changeover


Set up the circuit so that it is arranged as shown in Fig. 2.1.

Check the power supply.

Question 3

Items to be supplied by the centre (per set of apparatus unless otherwise specified)

- (i) Converging lens, focal length between 14 cm and 16 cm, with a suitable holder.
- (ii) Illuminated object with a triangular hole of height 1.5 cm (see Fig. 3.1 and Fig. 3.2). The hole is to be covered with thin, translucent paper (e.g. tracing paper). See note 2.
- (iii) Metre rule, graduated in mm.
- (iv) Screen. A white sheet of stiff card, approximately $15\,\mathrm{cm}\times15\,\mathrm{cm}$ and fixed to a wooden support, is suitable. See Fig. 3.3.



Notes

- 1. The lamp for the illuminated object should be a low voltage lamp, approximately 24 W or higher, with a suitable power supply.
- 2. The centre of the hole which forms the object, the lamp filament and the centre of the lens in its holder are all to be at the same height above the bench.
- **3.** The apparatus is to be situated away from direct sunlight.
- **4.** Spare lamps must be available.

Action at changeover

Check that the apparatus is ready for the next candidate.

Question 4
