General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

Safety

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.

Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do the experiment in Question 1 and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

Apparatus and materials

Question 1

Each student will require:

- (i) insect-pollinated flower of approximately 4–8 cm width, radially symmetrical with between 4 and 6 petals, and large enough to see the petals, carpel(s) and stamens easily.
- (ii) white tile
- (iii) forceps
- (iv) hand lens
- (v) 30 cm ruler graduated in mm
- (vi) 20 cm³ of a 10% glucose solution in a small beaker labelled **A**
To make 100 cm³ of solution **A** dissolve 10 g of glucose powder in 100 cm³ of distilled water.
- (vii) 20 cm³ of a 1% albumin solution in a beaker labelled **B**
To make 100 cm³ of solution **B** start by dissolving 1 g of albumin in a small amount of distilled water to make a paste. Top this up to 100 cm³ with distilled water. This should be tested to make sure that protein can be detected in it using the biuret test. If not, the concentration of albumin should be increased until it can be detected.
- (viii) 6 test-tubes
- (ix) at least 10 cm³ Benedict's solution labelled **Benedict's solution** with dropper **[MH]**
- (x) at least 10 cm³ biuret reagent labelled **biuret reagent** with dropper **[C] [MH]**
- (xi) iodine solution labelled **iodine solution** with dropper **[MH] [N]**
- (xii) test-tube rack or similar to hold 6 test-tubes
- (xiii) 2 beakers approximately 250 cm³ in size to act as water-baths, each labelled **water-bath**
- (xiv) supply of hot water at approximately 70 °C. Candidates will be instructed to raise their hand to indicate when they need hot water, which you should pour into each water-bath when asked.
- (xv) thermometer, –10 °C to +110 °C, with 1 °C graduations
- (xvi) stop-watch or sight of a clock
- (xvii) means of labelling glassware.

Question 2

Each student will require:

- (i) 30 cm ruler graduated in mm.
