

## General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

### Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

### During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the bar code label provided
  - the supervisor's results relevant to these candidates
  - the supervisor's reports relevant to these candidates
  - seating plans for each practical session, referring to each candidate by candidate number
  - the attendance register.

## Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do the experiment in Question 1 and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

### Question 1

Each candidate will require the following materials and apparatus.

- (i) 3 large test-tubes
- (ii) test-tube rack to hold 3 large test-tubes
- (iii) glass stirring rod
- (iv) 10 cm<sup>3</sup> syringe or measuring cylinder
- (v) three 1 g portions of dried active yeast in paper or foil packets each labelled **1 g yeast**

The yeast must be within its use-by date and opened a short time before the practical, to ensure that it is active.

- (vi) one 1 g portion of sucrose in a paper or foil packet labelled **1 g sugar**
- (vii) one 1 g portion of Truvia (a stevia-based sweetener) granules in a paper or foil packet labelled **1 g sugar substitute**
- (viii) beaker or suitable container with approximately 70 cm<sup>3</sup> of distilled water labelled **distilled water**
- (ix) beaker or suitable container to act as a water-bath for the 3 large test-tubes labelled **water-bath**
- (x) beaker or suitable container with water at approximately 20 °C labelled **cold water**
- (xi) hot water at approximately 50 °C

Candidates will raise their hands when they require it. This should be poured into the candidates' water-baths to a level of about two-thirds full by the supervisor.

- (xii) thermometer, –10 °C to +110 °C, with 1 °C graduations
- (xiii) stop-watch or sight of clock
- (xiv) ruler graduated in mm
- (xv) wax pencil or water-resistant marker
- (xvi) paper towels.

**Questions 2 and 3**

Each candidate will require the following materials and apparatus.

- (i) ruler graduated in mm.
