## General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

### Safety

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

### During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the bar code label provided
  - the supervisor's results relevant to these candidates
  - the supervisor's reports relevant to these candidates
  - seating plans for each practical session, referring to each candidate by candidate number

## Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do the experiments in Questions 1 and 2 and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

### Apparatus

The apparatus listed must be provided to each candidate.

#### Question 1

- 1 × 25 cm<sup>3</sup> volumetric pipette
- 1 × pipette filler
- 1 × 50 cm<sup>3</sup> burette
- 1 × stand
- 1 × burette clamp
- 1 × funnel for filling burette
- 1 × white tile
- 1 × conical flask or other suitable vessel for titration
- 1 × teat/dropping pipette
- 1 × beaker (100 cm<sup>3</sup> or 250 cm<sup>3</sup>)
- access to distilled water
- access to paper towels

#### Question 2

- 4 × test-tubes
- 1 × stopper to fit test-tubes
- 1 × test-tube rack
- 1 × boiling tube
- 1 × boiling tube holder suitable for heating
- 1 × wash bottle containing distilled water
- 1 × Bunsen burner and the means to light it
- 1 × heat-proof mat
- 1 × stirring rod
- a supply of teat/dropping pipettes
- 1 × beaker (for washing teat/dropping pipettes)
- paper towels
- red and blue litmus papers
- wooden splints
- apparatus normally used in the centre for flame tests
- apparatus normally used in the centre to test for carbon dioxide with limewater\*

\*If the apparatus normally used in the centre is a delivery tube and stopper, this equipment should be provided to fit both test-tubes and boiling tubes.

Candidates are expected to rinse and reuse test-tubes and boiling tubes where necessary. Additional tubes should be available.

## Materials

The materials listed in the table must be provided to each candidate. An excess of at least 10% of each material must be prepared to cover accidental loss.

**Warning:** small amounts of  $\text{NH}_3$  **[C][T][N]**, which can cause respiratory distress in some people, may be produced. **The laboratory must be well ventilated.**

<b>X</b>	150 cm <sup>3</sup>	0.50 mol/dm <sup>3</sup> hydrochloric acid	Dilute 42 cm <sup>3</sup> concentrated (35–37%; approximately 11 mol/dm <sup>3</sup> ), <b>HCl [C][MH]</b> to 1 dm <sup>3</sup> .
<b>Y</b>	150 cm <sup>3</sup>	0.20 mol/dm <sup>3</sup> sodium carbonate	Dissolve 57.2 g of $\text{Na}_2\text{CO}_3 \cdot 10\text{H}_2\text{O}$ <b>[MH]</b> in each dm <sup>3</sup> of solution. See preparation instructions in the 2023–25 syllabus.
<b>[T][C][N] [F][MH] [HH]</b>	2 cm <sup>3</sup>	methyl orange indicator	
Supervisors are asked to carry out a standard acid–base titration between solutions <b>X</b> and <b>Y</b> to ensure that the concentrations of the two solutions fall within the required range. It is essential that 25.0 cm <sup>3</sup> of <b>Y</b> reacts with between 18.0 cm <sup>3</sup> and 22.0 cm <sup>3</sup> of <b>X</b> .			
<b>Question 2</b>			
<b>P</b>	15 cm <sup>3</sup>	0.5 mol/dm <sup>3</sup> sodium nitrate	Dissolve 42.5 g of $\text{NaNO}_3$ <b>[MH]</b> in each dm <sup>3</sup> of solution.
<b>Q</b>	10 cm <sup>3</sup>	0.25 mol/dm <sup>3</sup> chromium(III) chloride	Dissolve 66.6 g of $\text{CrCl}_3 \cdot 6\text{H}_2\text{O}$ <b>[MH]</b> in each dm <sup>3</sup> of solution.
<b>aluminium</b>	1 cm <sup>2</sup>	aluminium foil	Additional samples should be available for any candidate who wants to repeat the experiment.

[C]	dilute nitric acid	5 cm <sup>3</sup>	1.0 mol/dm <sup>3</sup> HNO <sub>3</sub>	<p>See preparation instructions in the 2023–25 syllabus.</p> <p>If necessary, each of these reagents can be provided as a communal supply for groups of up to 6 candidates.</p> <p>Invigilators must be alert to the risk of contamination and the opportunity for malpractice when using a communal supply.</p>
[MH][N]	aqueous ammonia	15 cm <sup>3</sup>	1.0 mol/dm <sup>3</sup> NH <sub>3</sub>	
[C]	aqueous sodium hydroxide	20 cm <sup>3</sup>	1.0 mol/dm <sup>3</sup> NaOH	
	aqueous silver nitrate	5 cm <sup>3</sup>	0.05 mol/dm <sup>3</sup> AgNO <sub>3</sub>	
[MH]	limewater	10 cm <sup>3</sup>	saturated aqueous calcium hydroxide, Ca(OH) <sub>2</sub>
