### **General Marking Guidance**

- All candidates must receive the same treatment. Examiners must mark the last candidate in exactly the same way as they mark the first.
- Mark schemes should be applied positively. Candidates must be rewarded for what they have shown they can do rather than penalised for omissions.
- Examiners should mark according to the mark scheme not according to their perception of where the grade boundaries may lie.
- All the marks on the mark scheme are designed to be awarded. Examiners should always award full marks if deserved, i.e. if the answer matches the mark scheme. Examiners should also be prepared to award zero marks if the candidate's response is not worthy of credit according to the mark scheme.
- Where some judgement is required, mark schemes will provide the principles by which marks will be awarded and exemplification/indicative content will not be exhaustive.
- When examiners are in doubt regarding the application of the mark scheme to a candidate's response, a senior examiner must be consulted before a mark is given.
- Crossed out work should be marked **unless** the candidate has replaced it with an alternative response.

## Specific Marking Guidance

When deciding how to reward an answer, examiners should consult both the indicative content and the associated marking grid(s). When using a levels-based mark scheme, the 'best fit' approach should be used.

- Examiners should first decide which descriptor most closely matches the answer and place it in that level.
- The mark awarded within the level will be decided based on the quality of the answer and will be modified according to how securely all bullet points are displayed at that level.
- Indicative content is exactly that they are factual points that candidates are likely to use to construct their answer.
- It is possible for an answer to be constructed without mentioning some or all of these points, as long as they provide alternative responses to the indicative content that fulfils the requirements of the question. It is the examiner's responsibility to apply their professional judgement to the candidate's response in determining if the answer fulfils the requirements of the question.

### Placing a mark within a level

- Examiners should first decide which descriptor most closely matches the answer and place it in that level. The mark awarded within the level will be decided based on the quality of the answer and will be modified according to how securely all bullet points are displayed at that level.
- In cases of uneven performance, the points above will still apply. Candidates will be placed in the level that best describes their answer according to the descriptors in that level. Marks will be awarded towards the top or bottom of that level depending on how they have evidenced each of the descriptor bullet points.
- If the candidate's answer meets the requirements fully, markers should be prepared to award full marks within the level. The top mark in the level is used for work that is as good as can realistically be expected within that level.

**AO1** Demonstrate a close knowledge and understanding of texts, maintaining a critical style and presenting an informed personal engagement.

**AO2** Analyse the language, form and structure used by a writer to create meanings and effects.

**AO3** Explore links and connections between texts.

**AO4** Show understanding of the relationships between texts and the contexts in which they were written.

1	Candidates should write the text for their speech in a style and register suitable for their chosen audience, purpose and context, demonstrating their expertise and creativity in the use of English and their use of the stimulus texts.		
	Candidates' speeches must demonstrate:		
	<ul> <li>appropriate selection and adaptation of material from the source texts</li> <li>creative use of English to craft these materials into a new text which has an authentic voice and meets the requirements of the task.</li> </ul>		
	Candidates' speeches may be characterised by:		
	<ul> <li>application of the structures and rhetorical conventions of speeches</li> <li>predominantly Standard English lexis and grammar</li> <li>standard use of punctuation</li> <li>appropriate lexical fields</li> <li>use of discourse markers to signpost the reader</li> <li>effective grammatical transitions between paragraphs</li> <li>language to create a relationship with the audience</li> <li>adaptation of material from source texts through techniques such as direct quotation, narrative report of speech or paraphrase.</li> </ul>		
	N.B. Candidates must use material from the source texts in their answers; they may also use information from their own experience.

Candidates' commentaries should: • be written in an appropriate register and style • analyse and evaluate their lexical and semantic choices • analyse and evaluate their use of grammar and syntax • analyse and evaluate any features specific to the genre • show how the source texts have been reshaped to meet their new genre, audience and purpose • comment on the influence of contextual factors • show understanding of language concepts and issues relevant to the task and apply appropriate terminology to their analysis.
