## General Marking Guidance

- All candidates must receive the same treatment. Examiners must mark the first candidate in exactly the same way as they mark the last.

<b>21</b>	<p><b>The only correct answer is C.</b></p> <p>A is not correct as the text states that they visited 'family living nearby' when camping, not friends.</p> <p>B is not correct as the text states that Fiona 'avoided school camping trips' when she could.</p> <p>D is not correct as the text states that having to collect water when camping was one of the reasons why she did not enjoy her camping experiences.</p>	<b>1</b> (AO1c)
<b>22</b>	<p><b>The only correct answer is B.</b></p> <p>A is not correct as the text states that they had used a tent in the garden. There is no reference in the text to them not being able to put up a tent.</p> <p>C is not correct as it is not stated in the text that they did not want to buy camping equipment. Indeed, the text states that they always agreed they should attempt camping for real.</p> <p>D is not correct as in the text it does not mention any previous holidays that Fiona and her husband have taken with their sons.</p>	<b>1</b> (AO1c)
<b>23</b>	<p><b>The only correct answer is D.</b></p> <p>A is not correct as even though the text mentions camping being a cheap holiday option, Fiona did not set a budget to buy what the family needed.</p> <p>B is not correct as even though the text states that those who genuinely love camping speak of what fun it is, this was not a consideration in Fiona's planning of the trip.</p> <p>C is not correct as the text states that Fiona bought a few accessories, not as many as she could.</p>	<b>1</b> (AO1c)

<b>24</b>	<p><b>The only correct answer is A.</b></p> <p>B is not correct as the text states that the family picked a camping spot near the river and there were no others campers in sight. There is no mention of this spot being noisy.</p> <p>C is not correct because the text states the cafe is open for breakfast and lunch and open only on Friday evenings, for pizza night.</p> <p>D is not correct as the text does not mention the family struggling to find a camping spot, only that they picked a spot near the river, implying they had a choice.</p>	<b>1</b> (AO1c)
