- (b) Outline **one** possible **human** cause of high or extreme projected water scarcity in the countries shown on the map. [2]
- (c) Explain **two** ways in which local communities can improve access to safe water. [3 + 3]

- (b) Outline **one** impact of a hurricane on the physical environment of a coastal area. [2]
- (c) (i) Explain **one** benefit of aquaculture. [3]
- (ii) Explain **one** problem caused by aquaculture. [3]

- (c) Explain **two** possible conflicts over mineral extraction in cold extreme environments. [3 + 3]

- (b) Outline **one** way in which a volcanic hazard might impact human well-being. [2]
- (c) Explain **one** way in which communities may adapt to hazard risk through:
 - (i) government planning; [3]
 - (ii) personal resilience. [3]

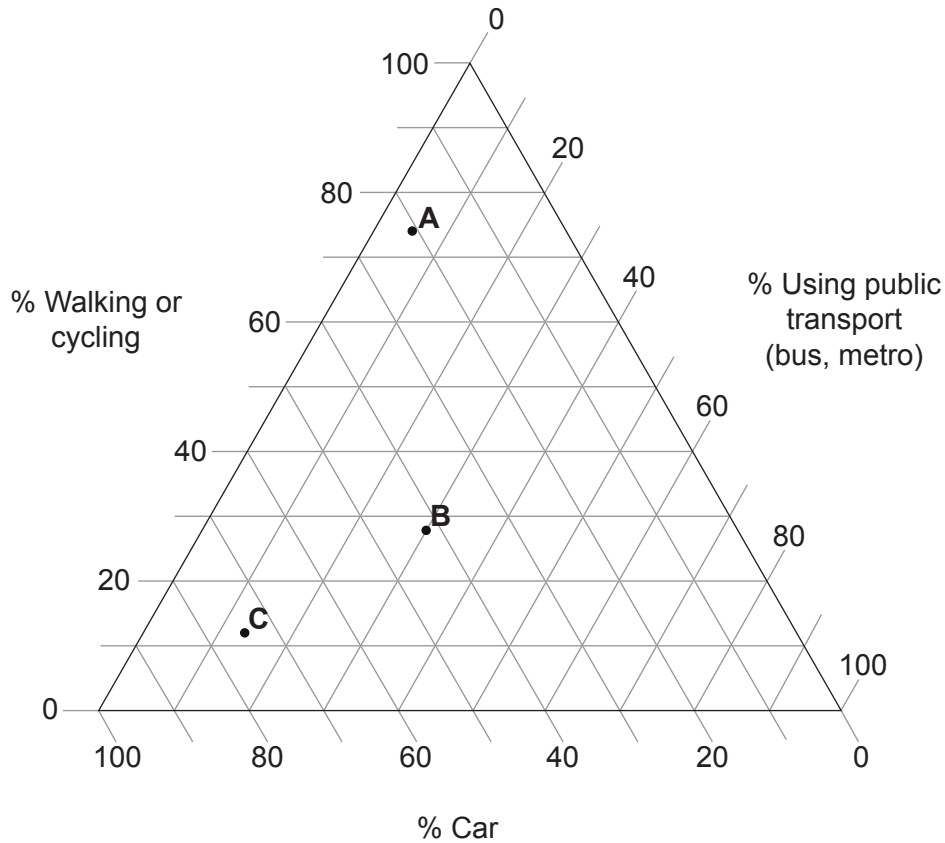
